**DEPOSIT:** A \$50.00 deposit to be applied toward your order is required when you receive your proofs...you may pay this at the time of your session.

### RETOUCHING:

There are NO additional Retouching or "Pose Selection" fees, with the exception of wallet-order orders (add \$10). The image retouching process cleans up facial lines, shadows, and blemishes. Retouching is not always necessary and we will advise you of this for your portrait.

### CORRECTIVE ARTWORK:

There is an additional (\$25 minimum) charge for artwork to remove glasses glare, stray hair, or large areas of shadow. We will give you an estimate.

**If you wear glasses we suggest you contact your eye doctor to borrow a pair of frames without lenses prior to your portrait session!!**

### "CAN I ORDER LATER"

Yes! If you need more photos we'll be glad to make more.

### "WILL YOU MAIL THE PHOTOS?"

For your convenience, previews or finished orders may be shipped UPS at your request. (Subject to surcharges and addl weight fees.)

### "HOW LONG?"

Proofs will be ready about 7 to 10 days after your sitting. Your finished portrait order will be ready about 5 weeks after it is placed. Deadline for Christmas is Wednesday before Thanksgiving.

As time goes by your portrait will have lasting value to your family. Choose from our selection of frames and portfolios to display your photographs

## Terms

- ✓Session fee is due at the time of photography.
- ✓When you receive your proofs a \$50 deposit is required. NOTE: Deposits will be applied to future orders, but are non-refundable after two weeks. In-store credit will be honored.
- ✓Payment of half the order balance due at time of order. We will apply your deposit toward your order.
- ✓Your order must be paid for in full before any part leaves the studio. PLEASE NO EXCEPTIONS!
- ✓We reserve the right to correct errors on estimates.
- ✓These prices are subject to change. They will be guaranteed for 30 days after you receive proofs.
- ✓Any orders not picked up within 30 days of completion will be charged 1.5% monthly interest.
- ✓Returned Checks will be charged \$25 penalty.
- ✓Mastercard, VISA, and Discover cards accepted.

## Digital Sessions/Services

- ✓You may see your photos on television right after your session, place your order or have a proof sheet printed to select your final order (see "online viewing" below and "Deposit" terms).
- ✓4x6 studio standard proofs can be printed from selected poses on your proof sheet at proof prices. These are unretouched with limited color correction.
- ✓After your portrait order, you may purchase .jpg images on CD. These are 72dpi suitable for sending via email only. Charges will be \$8 per image plus \$10 per cd production...\$30 minimum charge. For a screensaver or 800x600 wallpaper add \$10.

## Online proof viewing

For some occasions families may view proofs on our website. We can post selected previews for up to 60 days to an unlisted web address only you will be given access. Ask us about these online services. Add'l charge may apply if printed proofs are also provided.
